

**MINUTES OF THE PARISH COUNCIL MEETING HELD IN THE  
VILLAGE HALL ON WEDNESDAY, 5th SEPTEMBER 2001**

**OPEN FORUM**

PC Andy Vale reported five crimes since the last meeting, three involving thefts from motor vehicles at the Griffins Head. He emphasised the need for items to be placed out of sight.

Mr Wensley of Linby Lane gave a letter to PC Vale detailing a number of points he was concerned about including: speeding cars and motorbikes, position of the deregulation signs, warning signs approaching a 30mph area; speed traps and cameras. These items were discussed at length but due to a lack of resources PC Vale explained only hot spots were targeted and Papplewick was not included.

Mrs Kerr reported the 30mph signs on Forest Lane were obscured. House owner and farmer to be contacted.

Following the installation of traffic calming in the village Chairman asked those present if it had made a difference. The consensus was that there had been an improvement. Chairman confirmed the Council was working towards traffic calming measures for the north and south approaches including a 30mph restriction along Moor Road.

PC Vale confirmed appropriate warning letters would be sent to speeding drivers if registration numbers were passed on.

Mrs Kerr asked if further progress had been made re double white lines on Blidworth Waye. Cllr Womble confirmed County had marked the road for longer white lines but the area did not fit the criteria for double ones. It was understood work would not be undertaken until after the result of the fatality inquest was known.

Cllr Lonergan asked PC Vale the position with regard to the reorganisation. PC Vale understood Arnold would be the Area Command with a possible contact point at Ravenshead. He was still unable to confirm his own working area.

Mrs Kerr asked the Council to consider an extension to the pavement in front of the properties on the east side of Main Street. Cllr Womble suggested this would not be possible without the acquisition of land from property owners or reduction in the road width. Bearing in mind the cost and problems progressing the west side pavement improvement scheme he felt it would be too expensive and would prefer to see the other side improved.

Rubbish in the Linby Lane layby was discussed in view of the temporary closure of the Hucknall tip. Clerk confirmed 'Friends of Moor Pond Wood' to install a fence and Gedling had been approached regarding a 'No Tipping' sign. Mrs Womble reported tyres tipped on Forest Lane.

2. **MINUTES OF THE PARISH COUNCIL MEETING – 11TH JULY 2001**

With the addition of PC Andy Vale's name to the attendance list and an amendment to Item 9 (a) to read 'Parish Council resolved' Cllr Walker proposed acceptance, seconded by Cllr Passey and agreed.

3. **MATTERS ARISING FROM THE MINUTES**

**Open Forum – Item 1** 'Adding Up – Linby School. Clerk confirmed school not proceeding with the project. Cllr Walker pointed out the project had been undertaken on the basis of a planning exercise for the children but with only Papplewick village interested it was felt there was insufficient support for the project.

Queen's Golden Jubilee (page 3) Information provided of activities held during other events in the village. It was noted members of the Millennium Committee would help to organise an event. To be on the agenda for the next meeting. Cllr Passey proposed all residents of Moor Road be included which was agreed.

4. **HIGHWAYS**

**Blidworth Way** - Cllr Womble had met Mr G Woods (Gedling engineer) on site to discuss the flooding problem. The grates had since been cleaned out.

**Moor Road** - Clerk met Mr G Woods to discuss various problems. He had confirmed the grate on Forest Lane (outside No 2 Main Street/opposite Griffins Head) would be cleaned out. Also that flooding on the corner of Moor Road/Papplewick Lane would be tackled when scheduled drainage work was undertaken along Moor Road from No 269 down to the Grange Farm entrance. However, as they were four men down he could not confirm when this would be carried out.

Following the above meetings a letter received from Mr Nirmalendran of Gedling BC stating that as Agents, Gedling could not rectify the problems because 'they are only responsible for the maintenance of the existing infrastructure'. Cllrs felt this was an inadequate response and that maintenance was not being undertaken. Chris Charnley, Notts. CC Highways Manager to be informed cleaning schedule of grates inadequate and confirmation of their schedule to be requested.

**Footpath Forest Lane junction to Seven Mile House** – Clerk confirmed that Chris Charnley, had put forward this area as a contender for the Community Priorities Budget 2002/3 and Rural Footways Budget.

Chairman reported the footpath from No 43 to 63 Mansfield Road was overgrown with nettles. Clerk to contact Gedling BC.

**Linby Lane** – work to create layby anticipated during highway works in Linby/Bestwood. Clerk confirmed a letter had been sent to Mr Russell of 23 Linby Lane about the missing bollard. No response received – further letter to be sent.

Cllr Orton asked if Severn Trent could be contacted about the leak by the telephone box on Moor Road. This appeared to happen in heavy rain but the flooding was not rain water.

5. **PLANNING**

**Gedling Borough Council:**

2001/1063 - 51 Linby Lane (two storey extension) **No objections** but point made

that the plan was incorrect, in that there is no 'public footpath' to the rear of this property.

2001/1259 - 52 Main Street (single storey rear extension) **No objections.** However, on the application form it states no trees will be felled but on the plan it states that the applicant will confirm the evergreen trees to be removed. Could you please clarify this point.

2001/1309 – Papplewick Hall (Sundial to south front elevation) **No objections**

**Decision Notice** - 2001/0797 - 6 Clover Court (garage/porch extension, internal alterations and roof alterations) Application amended to incorporate facing stone to match existing dwelling.

**Appeals:** 2001/0252 - 145 Moor Road (first floor side extension)  
2001/0145/5 - 3, 4 and 5 Hall Mews (rear porches)

**Cornerstone Lodge, Main Street** – following complaints about the lack of visibility when existing from Church Lane, this had been checked by officers from Gedling and Notts. CC Highways Dept. The Borough Council's legal department being consulted.

#### **Ashfield District Council**

2001/0437 - Barn at Grange Farm (barn conversion/alteration) No objections but the following points made:

1. Traditional materials should be used, i.e. no plastic windows.
2. There is no mention within the application of garage or parking facilities. As it is likely that such a large property will need provision for parking/garaging of at least two vehicles we would wish to see a condition to ensure that this is included within the application site. Especially as this is a very busy farm access road used by large machinery.

#### 6. **VILLAGE HALL COMPUTER FACILITY**

Computer equipment now fully connected and operational. Clerk completed Notts. RPA's monitoring report and the first quarter's telephone account had been received. Agreed the facility now needed to be progressed. Cllr Hull confirmed letters sent to all Village Hall users but only one enquiry received. Action: To be included in the next Newsletter; Chairman to speak to Matthew Walster and Cllr Rosindell to set up a meeting of interested Cllrs to discuss way forward.

Cllr Hull confirmed software installed to enable digital camera connection.

#### 7. **VITAL VILLAGES**

Cllr Womble confirmed working group met to discuss outline of the Parish Plan. He then gave a computer presentation of what was proposed. The following headings would form the format of the report: Environment; Housing; Business; Transport; Community Services and Recreation. Draft proposals to be drawn up under these headings for consultation with the following timetable suggested:

September 2001 - February 2001 – compile consultative draft.  
March 2001 – launch consultation period at Parish Council meeting.

March-April 2001 – Six week consultation period (Cllrs to have copies for parishioners to see and comment on + public meeting)  
 June-September 2002 - Adopt final plan

The working group had budgeted for a total cost of £1,300 with 25% contribution from the Parish Council. Application completed for signature by the Chairman.

8. **VILLAGE BONFIRE**

Cllr Walker proposed permission be given to the bonfire committee to use the playing field, subject to the appropriate safety plan being drawn up and approved by the Chairman as in previous years. Cllr Rosindell agreed to represent the Parish Council.

9. **INSURANCE**

Clerk contacted Cornhill to ascertain if volunteers working in Moor Pond Wood would be covered under the Council's policy. Following receipt of their letter and further discussion between the Clerk and Cllrs Passey/Womble, as there seemed to be some anomalies which could affect volunteers including P3 work, an application had been submitted to the British Trust for Conservation Volunteers for insurance cover.

Chairman felt that if taking out the BTCV policy had covered all reasonable risks then he proposed ratification of that action which was unanimously agreed.

10. **ACCOUNTS**

Clerk confirmed the Audit had been finalised and approved accounts would shortly be received.

Cllr Womble asked for clarification of chq 000017 to North Notts Landscape. Clerk confirmed it was for the purchase of disabled access gates/fencing. He also queried the cost of the archaeologist. Cllr Walker/Clerk confirmed the total included a contingency plus the educational day when two local schools visited the site.

Chairman confirmed that he was one of the signatories on all large cheques, which was important as an internal audit measure.

Clerk reported a particularly high telephone account in respect of email connections. She had requested an itemised account to check this and would claim an appropriate amount at the next meeting. It was noted that as all Cllrs were now on email there would be a cost increase.

Chairman proposed the accounts be accepted, seconded Cllr Passey and agreed.

11. **NEWSLETTER**

Cllr Hull requested items for the next edition. Agreed this should be produced by the 28th September. Cllrs to forward items/information for inclusion.

12. **REPRESENTATIVE/COMMITTEE UPDATES**

- (a) **Moor Pond Wood** – Cllr Walker confirmed 'Friends' meetings organised for the last Friday of each month and the AGM on 28th September, at which a group member will be showing his birds of prey. He confirmed the group would be working to a short-term action plan, as the major works could not be undertaken until the autumn. A calendar of meetings with speakers and educational working parties being compiled.

The 'Friends' had installed a second disabled access gate plus chicane entrance on Papplewick Lane. A start was to be made on clearing the Grange Cottage site to

find out exactly what was needed. Ashfield DC being approached in case planning permission was needed to tip soil onto the site in order to regenerate it.

Events organised included 'Fungi' walk at 2.00 pm on Sunday, 30th September and Concert on 5th October at the Village Hall when the Shirland Band's 'mini-minstrels' training band would be performing with proceeds to the project.

**Funding** – Clerk confirmed a number of applications were being completed in respect of further funding towards disabled pathways, new paling fencing on Moor Road, seeding and strimmer.

- (b) **Parish Paths Partnership** – Cllr Womble confirmed the Strategy document consultation period ends 30th September. The next meeting would be on the 9th October and an account for cutting the Stanker Hill corridor section had been received from the contractor. It was noted that the VAT would need to be apportioned between Papplewick & Linby.
- (c) **Playing Field** – Cllr Orton reported work needed to the fence between the field and the Village Hall carpark. Cllr Hull estimated the cost at £85 for timber. The Committee recommended a new post and rail fence be installed. Wire along the rails was suggested for extra strength. Working party suggested to consider other remedial works including uneven slabs and pruning conifers. As part of the Moor Pond Wood project Cllr Walker confirmed that the 'Friends' were going to install a planked bridge across the leat from the wood to the south west corner of the recreation ground.
- (d) **Village Hall** – Cllr Passey reported that although work had been undertaken as part of the subsidence claim, an expert had inspected the main hall floor and the problem identified as the builder's responsibility. Forthcoming social events included a Barn Dance on the 22nd September and Tramps Supper on the 10th November.

### 13. **COUNCILLORS' REPORTS**

Cllr Orton reported that the hedge just below the Papplewick Lane entrance to Moor Pond Wood needed cutting back. Farmer to be contacted.

Cllr Walker reported overgrown vegetation on the footpath between Papplewick and Linby. Clerk to contact Gedling BC.
