The meeting commenced at 7.15 pm.

### **Open Forum**

A parishioner informed the meeting that Linby had recently had a 'clean up day' and was looking very nice. It was asked if this could be replicated in Papplewick? It was agreed that the Clerk would contact Kathryn Holmes to find out details. If it was possible to go ahead with a clean up day, then it would be advertised in the Newsletter.

Cllr Robinson mentioned that the path from Barracks Farm to Main St down Forest Lane was covered in rubble and needed clearing.

Cllr G McCracken mentioned that the grass needed cutting on Moor Rd.

The cross roads sign located on Main Street still needed cleaning. Clerk advised that this had been reported again today.

The weight limit sign on Moor Rd is bent.

Concerns were raised over the planning application for Papplewick Lodge and the possibility of increased traffic. The car park at the rear of the building already has permission for 15 cars, they are applying for 5 more, an increase to 20 places altogether in light of the application to convert the morning room into a tea room.
